## Caution

This appliance and its individual shut off valve must be disconnected from gas supply piping system during any pressure testing of that system at test pressures in excess of 1/2 psig (3.5 kPa).

This appliance must be isolated from the gas supply piping system by closing its individual manual shut off valve during any pressure testing of the gas supply piping system at test pressures equal to or less than 1/2 psig (3.5 kPa).

Do not use the fire feature if any part has been under water. Immediately call a qualified service technician to inspect the fire feature and to replace any part of the control system and any gas control which has been under water.

Power supply to the fireplace **must be shut off** before connecting or disconnecting the CAT5e cable to the touch screen/toggle switch wall receptacle. This also applies to the touch screen charging cable.

## Safety

Any grill, panel or door removed for servicing the unit must be replaced prior to operating. Failure to do so may create a hazardous condition.

Installation and repair should be done by a qualified service person. The appliance should be inspected before use and at least annually by a professional service person. More frequent cleaning may be required due to excessive lint from carpeting, bedding material, etc. It is imperative that control compartments, burners and circulating air passageways of the appliance be kept clean.

It is our policy that no responsibility is assumed by the Company or by any of its employees or representatives for any damages caused by an inoperable, inadequate, or unsafe condition which is the result, either directly or indirectly, of any improper operation or installation procedures.

This appliance must not be connected to a chimney flue serving a separate solid fuel burning appliance.



# — Important Note for the Commonwealth of Massachusetts —

From Massachusetts Rules and Regulations 248 CMR 5.08:

- (a) For all side wall horizontally vented gas fueled equipment installed in every dwelling, building or structure used in whole or in part for residential purposes, including those owned or operated by the Commonwealth and where the side wall exhaust vent termination is less than seven (7) feet above finished grade in the area of the venting, including but not limited to decks and porches, the following requirements shall be satisfied.
1. **INSTALLATION OF CARBON MONOXIDE DETECTORS.** At the time of installation of the side wall horizontal vented gas fueled equipment, the installing plumber or gas fitter shall observe that a hard wired carbon monoxide detector with an alarm and battery back-up is installed on the floor level where the gas equipment is to be installed, in addition, the installing plumber or gas fitter shall observe that a battery operated or hard-wired carbon monoxide detector with an alarm is installed on each additional level of the dwelling, building or structure served by the side wall horizontal vented gas fueled equipment. It shall be the responsibility of the property owner to secure the services of qualified licensed professionals for the installation of hard-wired carbon monoxide detectors.
- a. In the event that the side wall horizontally vented gas fueled equipment is installed in a crawl space or an attic, the hard-wired carbon monoxide detector with alarm and battery back-up may be installed on the next adjacent floor level.
- b. In the event that the requirements of this subdivision cannot be met at the time of completion of installation, the owner shall have a period of thirty (30) days to comply with the above requirements; provided, however, that during said thirty (30) day period, a battery operated carbon monoxide detector with an alarm shall be installed.
2. **APPROVED CARBON MONOXIDE DETECTORS.** Each carbon monoxide detector as required in accordance with the above provisions shall comply with NFPA 720 and be ANSI/UL 2034 listed as IAS certified.
3. **SIGNAGE.** A metal or plastic identification plate shall be permanently mounted to the exterior of the building at a minimum height of eight (8) feet above grade directly in line with the exhaust vent terminal for the horizontally vented gas fueled heating appliance or equipment. The sign shall read, in print size no less than one-half (1/2) inch in size, "GAS VENT DIRECTLY BELOW. KEEP CLEAR OF ALL OBSTRUCTIONS".
4. **INSPECTION.** The state or local gas inspector of the side wall horizontally vented gas fueled equipment shall not approve the installation unless, upon inspection, the inspector observes carbon monoxide detectors and signage installed in accordance with the provisions of 248 CMR 5.089(2)(a) 1 through 4.
- (b) **EXEMPTIONS.** The following equipment is exempt from 248 CMR 5.089(2)(a) 1 through 4.
1. The equipment listed in Chapter 10 entitled "Equipment Not Required To Be Vented" in the most current edition of NFPA 54 as adopted by the Board; and
  2. Product Approved side wall horizontal vented gas fueled equipment installed in a room or structure separate from the dwelling, building or structure used in whole or in part for residential purposes.
- (c) **MANUFACTURER REQUIREMENTS – GAS EQUIPMENT VENTING SYSTEM PROVIDED.** When the manufacturer of Product Approved side wall horizontally vented gas equipment provides a venting system design or venting system components with the equipment, the instructions provided by the manufacturer for installation of the equipment and the venting system shall include:
1. Detailed instructions for the installation of the venting system design or the venting system components; and
  2. A complete parts list for the venting system design or venting system.
- (d) **MANUFACTURER REQUIREMENTS – GAS EQUIPMENT VENTING SYSTEM NOT PROVIDED.** When the manufacturer of a Product Approved side wall horizontally vented gas fueled equipment does not provide the parts for venting the fuel gases, but identifies "special venting systems", the following requirements shall be satisfied by the manufacturer.
1. The referenced "special venting system" instructions shall be included with the appliance or equipment installation instructions; and
  2. The "special venting systems" shall be Product Approved by the Board, and the instructions for that system shall include a parts list and detailed installation instructions.
- (e) A copy of all installation instructions for all Product Approved side wall horizontally vented gas fueled equipment, all venting instructions, all parts lists for venting instructions, and/or all venting design instructions shall remain with the appliance or equipment at the completion of the installation.


## — Installation Requirements —

The fireplace installation and venting must conform to the current CAN/CGA-B149 installation code (in Canada) or the current National Fuel Gas Code, ANSI Z223.1 (in the USA), and approved per local codes. Only qualified (licensed or trained) personnel should install this product.

In the state of Massachusetts, only a licensed Plumber and Gas Fitter may install this product.

## Locating the Unit

Because the Architectural Series Linear Appliance is power vented, it can be located in a variety of places. Consideration must be taken for the location of the fresh air intake and the power vent unit venting. A site fabricated platform capable of supporting the appliances weight may be constructed to elevate the viewing area to the desired height, and so that it can accommodate the fresh air intakes (if bottom vented), gas supply and electrical supply.




Figure 1: Location options for Bottom Intake models.






Figure 2: Location options for Top Intake models.

## Framing and Finishing

### Bottom Intake Models




Figure 3: Stud securing points for bottom intake models.

Before framing and finishing, there are two important points to keep in mind:

1. When securing the top of the unit to the wooden studs, the screws must come through the metal framing from the center of the unit (Figure 3).




Figure 4: Facing attachment area for Bottom Intake models.

2. Facing material can be secured directly to the front and sides of the unit except in the areas indicated in this example by Figure 4. Each model will have its own specific areas in which screws must not be driven into.

Facing material may be screwed directly into the body of the appliance with the exception of areas indicated.

## Top Intake Models




Figure 5: Stud securing points for Top Intake models.

Before framing and finishing, there are two important points to keep in mind:

1. When securing wooden studs to the top of the unit, the screws can be secured through any part of the upper fastening area surface (Figure 5).




Figure 6: Facing attachment area for Top Intake models.

2. Facing material can be secured directly to the front and sides of the unit except in the areas indicated in this example in Figure 6. Each model will have its own specific areas in which screws must not be driven into.

Facing material may be screwed directly into the body of the appliance with the exception of areas indicated.

(Studs shown are for demonstration purposes only and do not indicate how the finished structure should be constructed)




Figure 7: Framing and facing.

**NOTE:** The architectural series fireplaces have a large amount of venting air being drawn through them. It is recommended to insulate the framework that encloses the venting above the fireplace with a sound-proofing insulation such as mineral wool, to reduce any air flow white noise.



## Facing Material




Figure 8: Leading edge of drywall.




Figure 9: Left side framing and facing view.

Because the unit requires no clearance to combustible material, drywall or other facing material can be affixed directly to the surface of the unit. Using standard 2x4's and 2x6's in the framing process allows for the edge of 1/2" drywall or other facing material to fit into the channels which make up the perimeter of the exterior glass sheets (Figure 8 and Figure 9).




Figure 10: Venting configurations for bottom intake models.

## Venting plenum

**Intake must be a minimum single wall, 26ga galvanized.**

**Exhaust must be 12" B-vent.**

**NOTE: Plenum must not be shared with other appliances.**

**Some installations - particularly in new renovations or with pre-existing constraints / obstacles may require the construction of a plenum in order to accommodate multiple air intakes.**

**The plenum must be made of furnace ducting (Minimum 26 gauge) or other material impervious to moisture. The constructed plenum must have a minimum cross-section of 150in<sup>2</sup> and be sealed to the air-intake collars on the appliance. The plenum may be transitioned to a single intake as long as the recommended cross-section is maintained.**

**For a single air intake, the rule of a maximum of 150 feet plus 6 elbows still applies.**




Figure 11: Venting configurations for Top Intake models.




Figure 12: Venting specifications for Bottom Intake models.

- Bottom Air intake venting uses three 7" standard single wall furnace grade venting material on 3-6ft burner models, and four 7" vents on 7-8ft models. All vent intakes must be used. Each intake line can be up to a maximum of 150 ft plus 6 elbows.
- Motorized dampers are optional.
- Exhaust venting uses 12" standard single wall furnace grade venting material. Maximum length is 150 ft plus 6 elbows.
- All Venting is zero clearance.
- All Vent seams (Intake and Exhaust) including elbow pivots must be sealed with high temperature aluminum tape.






Figure 13: Venting specifications for Top Intake models.

- Top Air intake venting uses two 10" vents on all models. Both lines must be used. Each intake line can be up to a maximum of 150 ft plus 6 elbows.
- Motorized dampers are optional.
- Exhaust venting uses 12" standard single wall furnace grade venting material. Maximum length is 150 ft plus 6 elbows.
- All Venting is zero clearance.
- All Vent seams (Intake and Exhaust) including elbow pivots must be sealed with high temperature aluminum tape.






Figure 14: 7 inch intake vent dimensions.



## Optional Motorized Damper

The optional motorized damper closes off air from the outside being able to enter the fireplace when the fireplace is off. This unit is mounted near the air intake vent. This unit is wired directly to the fireplace body (Figure 57 on page 41). One motorized damper is required for each of the air intake venting lines.

All bottom intake models use 7 inch motorized dampers if required for installation.

All top intake models use 10 inch motorized dampers if required for installation.




Figure 17: 7 inch Motorized damper dimensions.




Figure 18: 10 inch Motorized damper dimensions.



## Power Vent

This section is an overview of the Power Vent Installations. Consult the specific Power Vent Manual (included with each power vent) for up to date and detailed instructions.

**NOTE:** The installer must supply;

- An approved 14ga. household power wire from the fireplace to the Power Vent, for the 120VAC power. and,
- A minimum 18ga, 2 conductor (bell/alarm) wire from the fireplace to the power vent for the 24VAC Blower Control.

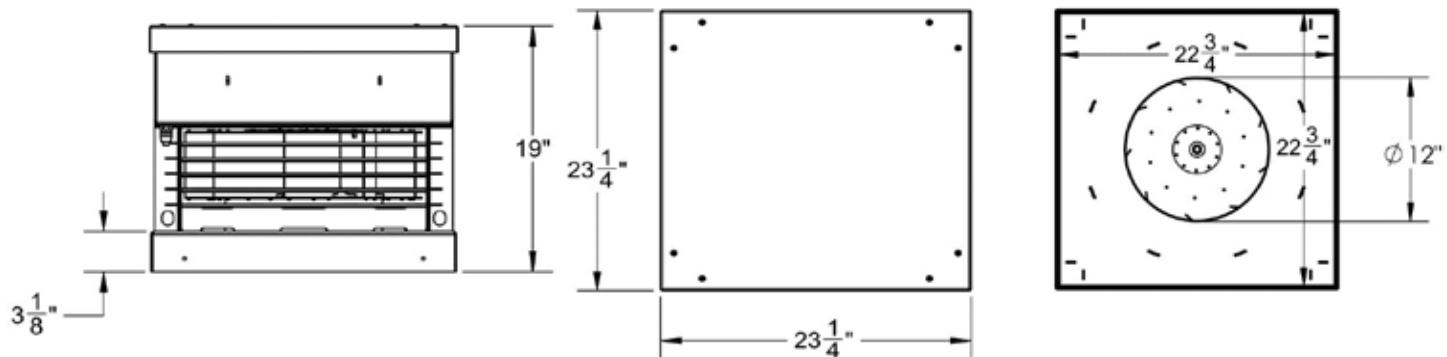




Figure 20: Power vent vertical installation.

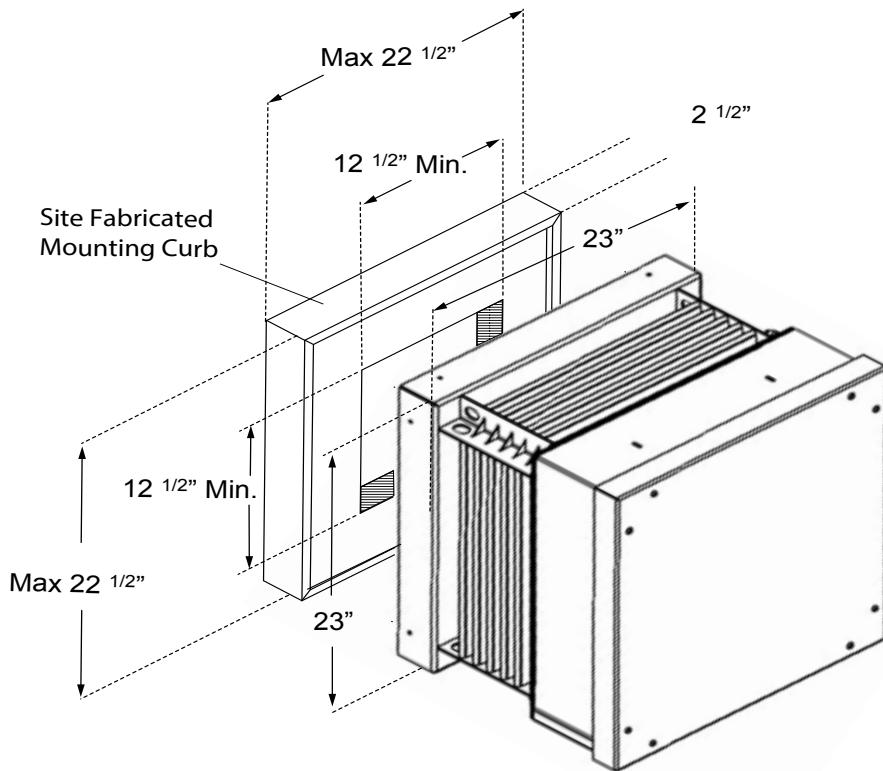



Figure 21: Power vent horizontal installation.

**When installing the power vent horizontally, ensure the side of the power vent with the attached electrical junction box is facing downwards.**

**Use exterior silicone/caulk around the base of the power vent to seal it to the building envelope.**

**Any horizontal run leading to the power vent shall be sloped down to the outside at a minimum of 1/4 inch per foot of vent length.**




Figure 23: T.S. Wiring diagram.




Figure 24: Architectural series power vent dimensions.




Figure 25: PV Framing Dimensions.




Figure 26: Fan - without grill,




Figure 27: FMPV Wiring Diagram.

The air baffle (Figure 28) is set to fully open before it is shipped and might need adjustment. However, if adjustment is required, the sliding plates can be moved by inserting a screwdriver or other object up through the baffle cover (Figure 29). There is a bracket on either end of the baffle to use for easy adjustment. If the flame pattern is too hectic, close the baffle opening a half inch at a time and monitor the flame with all glass panes installed.

**NOTE:** The more you close the baffle, the more the outer glass temperature will rise, as less heat is being evacuated from the combustion zone.

The baffle cover is secured by six bolts (Figure 29). If removal of the baffle cover is necessary, always remove the two center bolts last, as well as installing them first when re-installing the baffle cover.

All units ship with a multi-capped half inch NPT pipe for gas connection (Figure 30).

All units also ship with a gas valve shut-off (Figure 31). This shut-off handle is located on the right side of the glass door opening between the inner and outer glass panes. Push this handle down before installing the outer glass panes.

A sheet of optional black glass can be installed against the inner rear wall of the unit. To install:

1. Use the supplied suction cups to pick up the glass sheet and insert the top edge of the sheet into the slot which runs the length of the unit (Figure 33).
2. With the upper edge of the sheet fully inserted into the slot (Figure 34), place the sheet flat against the inner rear wall and lower the sheet into the lower slot (Figure 35).
3. Remove the suction cups.




Figure 36: Burner tray components.




Figure 37: Fitting edge of the burner into slot.

**The burner tray consists of 3 pieces - 2 identical long pieces and one small patch piece.**

1. The 2 long pieces fit on either side of the burner element.
2. Fit the edges of the long pieces fully into the slots as indicated in the inset of Figure 37.
3. Using a supplied screw, Install the small square patch over the hole at the opposite end from the pilot assembly (Figure 39).




Figure 40: Twilight Diamond crushed glass media.

The amount of crushed glass media provided is dependent on the length of the unit. Four pounds are allotted for each foot length of the unit.

Make sure the first 6 burner ports below the sparker rod are exposed, and not covered with glass media (Figure 42). This will give a strong flame at the rod to ensure ignition.



## Inside Glass Plate Installation




Figure 43: Install inside left and right panes first.




Figure 44: Left hand glass plate pushed toward rear wall.

1. Using the supplied glass suction handles, install the two inside end plates as shown in Figure 43. Once installed, push the plates toward the rear wall so that they are not contacted by the inside front plate when the inside front plate is installed (Figure 44).
2. Using the supplied glass suction handles, pick up and fit the upper edge of the inside front glass plate into its slot, angle the lower edge into a vertical position, and lower the plate into the bottom slot (Figure 45). Gently shift the front plate so that it is evenly centered if necessary.

3. Once the inside front glass plate is installed and centered, there will be a gap of about 1/4" in the corners between the side panes and front glass plate (Figure 46).




Figure 47: Final position of inside glass panes.

4. Using a suction glass handle, gently shift the inside left and right hand glass plates forward in their slots until they just touch the front plate (Figure 47).




Figure 48: Inside securing panels.




Figure 49: Left side securing panel installation.

Install the inside securing panels (Figure 48) into the space between the inner and outer front glass plates (Figure 49 and Figure 51). These securing panels are identical and have a flared edge which are installed so that the flared edges make contact with the inner glass sheet (Figure 50).

Make sure that the securing panel is pushed right up to the inside glass plate. This will keep any vibration to a minimum

Three plates of glass make up the outside set, two small side plates which are installed first followed by the large outside plate.

To install:

1. Using a supplied glass suction handle, lift the top edge of the small glass side plate into the narrow channels at the top edge of the trim (Figure 52 and Figure 53).
2. Insert the top edge of each of the side plates into the top channels, lower the plate to a vertical position, and lower the plate into the bottom channels. Once the plates are in the lower channels, shift them toward the rear wall - as was done with the inside side panels (See Figure 44 on page 36) so as to create enough room so that when the large outside front plate is installed it does not come into contact with the 2 smaller side plates and potentially break them.
3. Install the large outside front glass plate (Figure 54) as was done with the inside plate (see Figure 45 on page 36).




Figure 55: Electrical connection panel removed exposing connection box.




Figure 56: Inside of electrical connection box.

Power to this unit is 120VAC. The electrical connection boxes are located behind a removable panel that runs the length of the lower side of the appliance. After the panel is removed, the electrical connection box cover can be removed to access the wiring (Figure 56). Once wiring is completed (See “Figure 59” on page 42), power will be supplied to both the power vent and the main unit control module. The optional motorized dampers wiring is located behind the removable panel as well in the second connection box (Figure 59). There will be a pair of wires for the appropriate number of dampers specified for the appliance. These wires are not polar specific. Low voltage wiring can be used for connecting the dampers. The CAT5e cable is located here as well. Connect the Cat5e cable to the control panel wall receptacle. Ensure the wiring strain relief clamps are snug and secure.

Re-attach the box covers, followed by the compartment panel when all wiring is complete. Use aluminum tape to seal all seams of the compartment panel before attaching facing material.




Figure 57: Motorized damper electrical connections.




Figure 58: Wiring at fireplace - power.




Figure 59: Wiring at fireplace - Dampers and controls.

## Control Panel Installation

**NOTE:** Make sure that the ON/OFF switch is in the ON position before mounting the touch pad in its frame.

**NOTE:** Make sure that the AC power to this appliance is turned off before installing or servicing the touch pad.




Figure 60: Individual LED section.




Figure 61: LED individual sections joined together.




Figure 62: LED connector.

There are two rows of LED lights in this fire feature, one row on each side of the burner. Each row of LED lights is made of individual LED sections which can be joined together using bridge connectors to achieve the desired row length (Figure 61). Each row of sections also has its own main electrical connector (Figure 62).

## Removing an LED section

1. To remove an individual LED section or sections, begin by disconnecting the main power to the fire feature at the main circuit breaker. Give time for the unit to cool down.
2. Remove the glass panels.
3. Remove the glass media and the relavent glass tray.
4. Disconnect the main electrical connection located on the left hand side of the fire feature by lifting the connector up as shown in Figure 62.




Figure 63: LED strip bridge connector.




Figure 64: LED strip hold down tabs.

5. Remove the bridge connector of the LED section(s) to be replaced (Figure 63). These connector tabs lift up much like the main electrical connector. In this way, individual LED sections can be replaced without removing the entire row of LED sections from the fire feature.
6. The LED sections and rows are held in place by hold down tabs (Figure 64). These tabs can be lifted up so that the LED section can be removed.
7. When removing an individual LED section, lift up the side of the LED section next to the tabs that were just moved upwards and then remove the LED section (Figure 65).




Figure 66: Arrows always meet.

**NOTE: When replacing an LED section, make sure that the arrows on the sections meet as shown in Figure 66. Whether joining full sized sections to other full sized sections, or when joining a full sized section to a short section, the arrows must meet each other. As you stand in front of the fire feature, the arrows will be located on the sides of the sections furthest away from you.**

8. Reconnect the individual LED sections using a bridge connector as shown in Figure 63.
9. Reconnect the main electrical connector as shown in Figure 62.
10. Return the glass tray(s), glass media and glass panels to their original positions.

## ANNUAL INSPECTION:

- a) Remove glass panel and inspect the Burner and Igniter for soot build up. If excessive build up of soot is present, have a qualified service person inspect and adjust the unit for proper combustion.
- b) Check that the venting pipe and venting terminal are open and free from blockage or debris. If the venting is disassembled for cleaning, it must be properly assembled and re-sealed. Refer to VENTING section for proper procedure.

**Note: The appliance area must be kept clear and free from combustible materials, gasoline and other flammable vapours and liquids.**

## Periodically:

- a) Viewing glass may be cleaned as necessary with fireplace glass cleaner.

## CAUTION:

Do not use abrasive cleaners on glass or any other part of the fire feature.

Do not clean glass when hot.
